This award was instituted in 2013 in honor of FIU Intelligence Coordinator Wayne Dickey. Wayne served the law enforcement Intelligence community for over 40 years. Even after retiring from the Florida Department of Law Enforcement, he continued to serve as the Intelligence Coordinator for FIU. This award was developed to honor Wayne and the Intelligence investigators/analysts of the 21st Century that are striving for the same excellence that Wayne was able to exemplify. This includes, but is not limited to, the nominee's agency head, other law enforcement officials, elected officials, fellow officers, community leaders, interested citizens, and FIU members. All nomination shall be received by 5:00pm on July 31. The award committee will receive all nominations and submit their recommendation to the FIU Board of Directors no later than August 15. The winner's agency head will be notified upon final selection. The award will be presented at the Annual FIU Conference in September.

CRITERIA

- The nominee must have been able to contribute significantly to the law enforcement /homeland security intelligence community through one significant event or a series of lesser events that culminated to being noteworthy. Examples include, but are not limited to: significant contribution to, or solving major case(s), promotion of criminal intelligence, successful case closures through intelligence sharing, data mining, intelligence product dissemination, etc., superior intelligence product development, subject matter expert in intelligence related fields, intelligence training,
- The act(s) included in the nomination must have occurred in 2017 or 2018. Historical acts (briefly explained) used to support the more recent incidents will be acceptable and are encouraged.
- The whole person concept is important. If applicable, provide information concerning extra-curricular activities that are also exemplar.

ELIGIBILITY

To be eligible for nomination as E. Wayne Dickey Excellence In Criminal Intelligence Award, nominees must be: Law Enforcement Officers, or civilian Intelligence Analyst and/or Crime Analyst. You may nominate more than one individual if they worked together as a team and were involved in the same incident or project. This will count as one nomination.
